A model for economic growth in Whatcom County: The Trail Town Program along the Great Allegheny Passage

The Great Allegheny Passage (GAP) is a multi-use pedestrian path that connects Washington, DC to Pittsburgh, PA, traversing rural Pennsylvania and Maryland. It contributes \$50 million annually to rural economies. In Whatcom County, the Bay to Baker Trail has been in the planning states for decades, but little has been accomplished.

David Kahley, is President & CEO of The Progress Fund and its Trail Town Program®, which has been instrumental in the development of a rural tourism industry along the Great Allegheny Passage. Mr. Kahley moved to Washington in 1985, to start and run the Port Townsend Main Street Project. After running the Bellevue Transportation Management Association, he returned to Pennsylvania in 1995 to start The Progress Fund, utilizing what he learned in Washington to create an exciting new program.

Mr. Kahley has climbed and skied extensively in the North Cascades. According to Mr. Kahley, "The parallels between rural Pennsylvania and Whatcom County are staggering. Both economies trend strongly towards outdoor recreation and tourism, and in many ways, the rural nature and pristine environments of both is their greatest asset. The GAP Trail has fundamentally transformed the economy of our region. This has all been accomplished while maintaining its quiet, rural nature, and enhancing quality of life for residents. I am excited to return to share my experiences, and to explore the opportunities available to the area."

Mr. Kahley will be addressing the Whatcom County Counsel on September 15, 2015, with a 45-minute presentation on how and why the GAP was such an economic success, and what we need to execute to realize those same benefits.
