## **Plaintiff's Summary**

On April 3, 2016, at approximately 11:30 am, I was skiing in Bear Creek outside of Telluride Resort in San Miguel County with my friend Greg Hope. At the top of our line, we saw another two-person party (Chris Parke and another man whose name was not given) who were planning to ski the same line. The other party was not ready to go when we were, so they told us we could go before them. We all had cell reception. In order to avoid an incident and stay safe, we made a plan to call them when we were out of the couloir and in a safe zone. It was communicated and agreed that Parke and his partner would wait for our call. Unfortunately, they did not wait- they skied while we were still in the chute, and they triggered an avalanche on top of us. I was on rappel at the time of the avalanche, and was ripped off the rope and fell 1200 feet and suffered several injuries. We waited for them at the bottom of the chute, and Parke admitted that they triggered the avalanche and agreed to pay for medical bills. I received \$588.75 from Parke. However, after a few payments, they stopped. I still have nearly \$12,000 in medical bills related to this incident. Despite efforts to reconcile with Parke, he has refused to pay any more of them.
